## **CSCSOCAL currently offers three types of membership:**

1. **Regular membership** – dues are \$15.00 a calendar year. A regular member may vote and hold office, must be in good standing with AKC and subscribe to the purpose of this club. A member applying for regular membership must attend least two meetings in a six month period.

2. **Family membership** – dues are \$25.00 a calendar year. All members of the household are eligible for membership providing they are in good standing with the AKC and subscribe to the purpose of this club. The family members may be regular members, associate members, or junior members. Please list names and type of membership applied for (regular, associate, or junior):

3. **Junior membership** – Junior members must be in residence at a dues paying regular member's household. If no other member of their family is a regular member, the junior member will be assessed the regular dues of \$15.00 a calendar year. This is for persons under the age of eighteen who are in good standing with the AKC and subscribe to the purpose of this club. This membership requires payment of dues but may not vote or hold office. The member will be mailed newsletters, and be informed of and invited to all club meetings and activities.

CSCSOCAL meetings are held February, April, June August, October and December. The date, time and location of each meeting will be announced to the membership and on the club's website <https://www.cockerspanielclubofsocal.com>.
